In pursuance to Directorate of Skill Development J&K's Admission Notice issued under endorsement No. DSD/401/Trgs/2025/1521-1611 Dated:- 08-05-2025, Online applications are invited from eligible candidates with effect from **15th May, 2025 to 30th May, 2025** seeking admission in **Govt. ITI Doda** for the academic session 2025-26-27 in various trades/courses (Engineering/Non Engineering trades) having duration of Two years/One year being run in this institute under NCVT/SCVT Schemes for which the forms can be uploaded on admission portal from **15th May, 2025**.

The desirous candidates having minimum age of **14 years as on 1st September 2025**, with no upper age bar have to fill up the admission forms available online at ITI admission portal viz. (<https://itiadmissions.jkdsd.in>) link is also present on the official website of Directorate of Skill Development J&K i.e. www.jkdsd.in. The detail of trades functioning in Govt. The candidates have to fill up the complete details which include basic details of students like name, parentage, qualification etc online in the portal and have to upload the soft copies of the following documents online only:

1. Marks Certificate of Qualifying Examination.
2. Date of Birth Certificate.
3. Category Certificate (SC/ST/Ex-serviceman/OBC/EWS/Physically Handicapped/EWS) if any.
4. Aadhar Card.
5. Domicile Certificate should be produced at the time of admission.

The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application completed in all respects along with self-attested documents uploaded on the portal & the prescribed fee of **Rs. 100 (One Hundred Only)** per three trades at Govt. ITI Doda against a proper receipt.

1. The applying candidates has to submit printout of system generated application along with requisite self- attested documents at Govt. ITI Doda.
2. The candidate shall deposit the fee @Rs. 100/= **(One Hundred Only) per Three trades at Govt. ITI Doda** against proper receipt.
3. Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination (both for free and self-financing seats separately).
4. On successful completion of training in trades running under NCVET/SCVET Scheme, certificate will be awarded by National/State Council for Vocational Education & Training.
5. Candidates who have already undergone training in any of the trades in any ITI can apply for admissions in another trade after two years after completion of previous training course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.
6. Candidates should have unique mobile Number and e-mail address and to maintain it till completion of course and receiving of the certificate, as change is not permitted later.
