**Subject:- Abbreviated Tender Notice for Purchase of Raw Material under Normal Scheme for the year 2018-19.**

Sealed tenders duly affixed with revenue stamps worth Rs. 5/- only are from the reputed Registered Firms/Reputed manufactures/Authorized Dealers/Suppliers for purchase of raw material for use in this institute for the year 2018-19. The interested tenderer may obtain of items with detailed specification together with prescribed terms & conditions from the office of the undersigned against the payment of Rs.200/- as cost of Tender document through Indian Postal Order/DD in favour of Superintendent ITI Doda payable at Doda. The Documents can be send on above mentioned address along with Indian Postal order/DD of Rs.200/-list of which can had from the office of the Undersigned w-e-f 10/05/2018 to 24/05/2018 and last date for receipt of tender will be 25/05/2018 up to 04:00PM.

The Tender should be accompanied with CDR of Rs. 2000/- which should be pledged to "Superintendent ITI Doda" without which no tender will be entertained. The rates will remain valid up to 31/03/2018. The desirous tenderer may participate in person or through their representative, on the date of opening of tenders which will be 28/05/2018 at 02:00PM in the office Chamber of the Superintendent ITI Doda.

**Terms and Conditions**

- 01) The successful Tenderer shall have to supply the material in full failing which the firm shall loose the security deposit. The Payment of the entire supply will be made after verification by the verifying committee and the material is supplied in full as per supply order.
- 02) The successful Tenderers/suppliers have to deliver the material with in fifteen days from the date of the supply order.
- 03) The successful Tenderers may quote the TIN No. etc of their firm with regard to sale tax etc.
- 04) The rates should be quoted either typed or with ink without any correction/erasing on the list of items appended with this notice. The rates quoted should be covered with cello tape to avoid any insertion.
- 05) Tax Clearance certificate in the prescribed form issued by the assessing Authority should also be furnished up to the last financial year viz.31/03/2018.
- 06) Only the items of standard companies (i-e companies having ISO 9001-2000 certificates) will be given supply orders. Also Bidders/Tenderer must mention make, against each item only then their rates will be considered.

- 07) The Superintendent ITI Doda reserves the right to accept or reject any tender or part thereof without assigning any reason.
- 08) Bidder/Tenderer must quote specification of each item of the package failing which the tender shall be rejected.
- 09) Bid/offer for any Sub-standard item will be treated as rejection of whole tender.
- 10) In case of the successful bidders fails to supply the ordered material in full, penalty @2% (two percent) of the total cost of the order shall be imposed upon him/them.
- 11) Whenever it is felt necessary to call samples of items, the supplier has to submit the sample within seven days period at their own cost.
- 12) Rates should be strictly quoted inclusive of all taxes (VAT, GST, Entry Tax, other taxes etc)freight levies applicable at the time of supplies and quoted F.O.R ITI Doda premises.
- 13) The rates be quoted only against specified items, on the space kept against the items, whatever possible. In case of specification, the committee shall have the right to take decision at the time of finalization of tender.
- 14) At the time of procurement if DGS&D (Gem) rates are available for any item the Superintendent reserves the right to procure the same on the rate contract & exclude the item from the tender. In that case no tenderer has any claim whatsoever over the said item.
- 15) The successful Bidder/Tenderer shall have to execute an agreement with the Superintendent, ITI Doda within Ten days after acceptance of the tender is communicated to him, failure to execute such agreement shall not prevent to the terms and conditions embodied herein being enforced against him and any loss sustained by the department in re-tendering shall be recovered from him besides forfeiture of the security deposit.


