ONLINE ADMISSION NOTIFICATION 2021-22-23

In pursuance to Director Skill Development J&K Srinagar's Admission Notice issued under endorsement No. DSD/401/Trgs/2021/44-135 dated:- 15/07/2021, Online applications are invited from desirous candidates for seeking admission in Govt. ITI Doda for the academic session 2021-22-23 under various trades/courses (Engineering/Non Engineering trades) having duration of Two years/One year being run in this institute under NCVT/SCVT Schemes and commencing from September 2021, for which the forms can be uploaded from **16th of July 2021**.

The desirous candidates having minimum age of **14 years as on 1st of June 2021** with no upper age bar have to fill up the admission forms available online at ITI admission link (<http://itiadmissions.jkdspd.org>) present on the official website of Directorate of Skill Development J&K i.e. www.jkdspd.org.

The last date for applying online is up to **05th of August 2021**. The candidates have fill up the complete details which include basic details of students like name parentage etc. and qualification details online in the portal and have to upload the soft copies in **.jpg format (with size between 20KB to 300KB)** of the following documents online only:

1. **Marks Certificate of Qualifying Examination.**
2. **Date of Birth Certificate.**
3. **Category Certificate (SC/ST/Ex-serviceman/Physically Handicapped/EWS) if any.**
4. **Aadhar Card.**

(Domicile Certificate should be produced at the time of admission in the respective ITI).**

The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application completed in all respects along with self-attested documents uploaded on the portal and deposit the prescribed fee of **Rs. 100 (One Hundred Only)** per Three trades against a proper receipt in Govt. ITI Doda.



1. The applying candidates has to submit printout of system generated application along with requisite self- attested documents at Govt. ITI 100/= **(One Hundred Only) per Three trades at Govt. ITI Doda against proper receipt.**
2. Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination (both for free and self financing seats separately).
3. On successful completion of training in trades running under NCVT/SCVT Scheme, certificate will be awarded by National / State Council for Vocational Training.
4. Candidates who have already undergone training in any of the trades in any ITI can apply for admissions in another trade after two years after completion of previous training course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.
