02	Stenographer and Secretarial Assistant (English) Self Financing Trade (SCVT)	B.Voc/ Degree in Commerce / Arts (with Short-hand & Typing) from a UGC recognized university with one year experience in the relevant field. OR Diploma (Minimum 2 years) in Commercial Practice from recognised board or relevant Advanced Diploma (Vocational) with two years' experience in the relevant field. OR NTC/ NAC passed in the trade of Stenographer Secretarial Assistant (English) with three years' experience in the relevant field. Essential Qualification: Relevant Regular / RPL variants of National Craft Instructor Certificate (NCIC) under DGT.
